## How long do we keep personal data

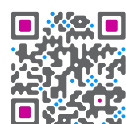

## Sharing of personal data with third parties

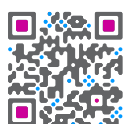
#### View, modify or delete data

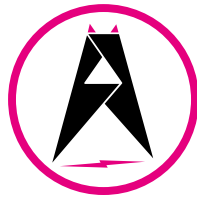
