For what purpose and on what basis we process personal data

Coöperatie ArtiShock U.A. processes your personal data for the following purposes:

- Handling your payment
- Sending our newsletter and / or advertising brochure
- To be able to call or e-mail you if necessary to carry out our services
- To inform you about changes to our services and products
- To deliver goods and services to you
- Coöperatie ArtiShock U.A. also processes personal data if we are legally obliged to do so, such as information that we need for our tax return.

Automated decision-making

Coöperatie ArtiShock U.A. does not take decisions based on automated processing on matters that can have (significant) consequences for people. These are decisions taken by computer programs or systems, without involving a person (for example an employee of Coöperatie ArtiShock U.A.). Coöperatie ArtiShock U.A. uses the following computer programs or systems:

Outlook, Gmail and a contact information application.

How long do we keep personal data

Coöperatie ArtiShock U.A. does not store your personal data longer than is strictly necessary to realize the purposes for which your data is collected. We use the following retention periods for the following (categories) of personal data: As long as you are a customer or supplier with us, the data will be kept until you indicate that you want us to delete it.

Sharing of personal data with third parties

Coöperatie ArtiShock U.A. will not sell your information to third parties and will only provide it if this is necessary for the execution of our agreement with you or to comply with a legal obligation. We conclude a processor agreement with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. Coöperatie ArtiShock U.A. remains responsible for these processing operations.

Cookies, or similar techniques, that we use

Coöperatie ArtiShock U.A. uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. Coöperatie ArtiShock U.A. uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered. These cookies are also used to make the website work properly and to be able to optimize it. In addition, we place cookies that keep track of your surfing behavior so that we can offer customized content and advertisements.

With a retention period of approximately 2 years

View, modify or delete data

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Cooperatie ArtiShock U.A. and you have the right to data portability. This means that you can submit a request to us to send the personal data that we have about you in a computer file to you or another organization mentioned by you.

You can send a request for access, correction, deletion, data transfer of your personal data or request for cancellation of your consent or objection to the processing of your personal data to projects@artishock.com.

To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks.
